

1. Introduction

The Brandeston Parish Plan (BPP) is being compiled so that villagers may state their views and expectations for the future of Brandeston. This plan will be presented to local authorities as a definitive statement intended to influence development plans affecting the village. The plan, however, is not binding on those authorities but will provide a mandate for the Parish Council in its dealings with them.

The BPP is being defined by an elected Steering Group of residents who are committed to act on behalf of the community and under the watchful eye of the Parish Council. However, in order for the Steering Group to present its findings accurately, all villagers must be consulted in an open and democratic manner and this questionnaire is one part of that process. All BPP meetings are open to villagers.

The Steering Group therefore requests and invites each person **resident** in your household to complete the questionnaire. This will be personally collected for collation so that we can ensure everyone is canvassed.

Please note: to be eligible to complete the questionnaire you must be resident in Brandeston and on the Electoral Roll, but including children over the age of 10 and any temporary residents such as students or regular visitors.

The form has room for 4 people to respond per household. Should you have more than 4 **eligible** people, please ask your volunteer collector for an additional copy.

Confidentiality and Sensitivity

Names are not included in the questionnaire and all answers will be treated confidentially, and collated anonymously, so that nothing can be traced back to individuals or households.

We recognize that some questions are of a sensitive nature (eg agerange) but would encourage you to answer them so that we can compile representative statistics on what Brandestonians want but, of course, this is not compulsory.

Incentive!

All households returning a questionnaire will be entered in a prize draw from which there will be 4 prizes of £25!

Results

Once the information has been analysed an initial report will be presented for public scrutiny, review and consultation before forwarding to the local authorities. Meetings will be held to derive an Action Plan for the future of Brandeston, to be used by the Parish Council as a mandate for its negotiations with Local Government and to outline what the village can do for itself.

Minutes of all proceedings are published in a folder in the Village Hall foyer and on the Brandeston website for open review.
